## ORDER

The Government of Andhra Pradesh has taken over the NBT & NVC. College, Narasaraopet, Guntur dist under section 60 of the AP Education Act,1982 in the public Interest, since the Management of the college and for violating the section 25 and 31 of the AP Education Act,1982.

Accordingly as per the reference 2<sup>nd</sup> cited, the Special Commissioner of Collegiate Education, AP, Vijayawada has appointed the collector and District Collector & Magistrate, Guntur as special officer and requested him to take over the Management along with the infrastructure, records, computers, building and etc. Under section 4 of the section 60 of the AP Education Act,1982 all persons in whóm in the Management of the Educational Institution vested immediately before taking over shall cease to be so vested and shall be deemed to have vacated their offices with immediate effect. As per the reference 3<sup>rd</sup> cited, the District Collector & Magistrate, Guntur has assumed charge as Special officer on 31.03.2017 and directed the RDO, Narasaraopet was authorized and directed to take over complete charg of the Infrastructure, records, computers, buildings and etc., from the Correspondent of the College.

The RDO, Narasaraopet along with Tahasildar, Narasaraopet and other officials proceeded to NBT & NVC. College, Narasaraopet and since the Secretary & Correspondent of the College was not available at that time he has taken over the complete charge of the infrastructure, building and etc of NBT & NVC. College and Hostel as available on the ground under the cover of

mediatornama on 31.03.2017. He entire seized material has been handed over to the Tahasildar, Nrasaraopet for safe custody under proper acknowledgment on 31.03.2017. vide reference  $4^{\mathrm{th}}$  read above. As per the reference  $5^{\mathrm{th}}$  cited, the Collector and District Magistrate, Guntur has allotted the NBT & NVC. College, Narasaraopet to the JNTUK for location of their College of Engineering, Narasaraopeta until further orders and directed the RDO, Narasaraopet to handover the buildings along with the infrastructure available in NBT & NVC. College and Hostel to the JNTUK Authorities under proper acknowledgement.

As per the reference  $6^{\text{th}}$  cited, on telephonic directions of - the Special Commissioner of Collegiate Education, AP, Vijayawada the Regional Joint Director of Collegiate Education, Guntur has issued orders keeping the Principal, Govt. Degree College, Vinukonda, Guntur Dist as Principal Incharg of the defunct NBT & NVC College, Narasaraopet, Guntur. The Principal incharg ie., Principal, Govt. Degree College, Vinukonda, Guntur Dist vide reference  $7^{\text{th}}$  cited has stated that the old students, those who are failed and want to appear for their University Exams are pressuriging him to sing on their applications and also some students demanding the T.C's, Study certificates, Conduct certificates issuing of Marks Memos etc, and the retired staff asaking for their Service Registers for claiming their E.L encashment etc, he has requested the Regional Joint Director of Collegiate Education, Guntur to take steps for transfer of the requested student relevant records and the Service Registers of the staff members to the nearby aided college ie., S.S.N.College, Narasaraopet for the sake of students and the retired staff as the Govt. Degree College is not available in Narasaraopeta Town. In this connection, on the advice of Revenue Divisional officer, Narasaraopeta has decided to transmit the relevant required records from NBT & NVC  $\,$ College campus to S.S.N. College Narasaraopet duly entrusting the job to the Principal, S.S.N. College, Narasaraopet to attend to the students and staff need of the NBT & NVC College, Narasaraopeta.
